4. The bidding document which has been prepared in the English language shall be purchased by interested bidders at 8(b) upon payment of a non-refundable fee of **UGX. 100,000** . The method of payment will be by obtaining a **payment reference number (PRN)** after which a general receipt shall be issued from Makindye Ssabagabo Municipal Council Finance Department.
5. Bids must be delivered physically to the address below at 8(c) at or before **10:00 a.m on 1st December, 2025**. All bids must be accompanied by a bid security/Bid securing declaration where applicable *as listed in the table above*. Bid securities/Bid Securing Declaration must be valid until **25th June, 2026**.

6. Electronic bidding **shall not** be permitted. Late bids shall be rejected. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below at 8(d) at **11:00 a.m EAT on 1st December,2025.**
7. There shall be a pre-bid meeting at **Makindye Ssabagabo Municipal Council** on the **18th November,2025 at 10:00 a.m** thereafter shall be a site visit at JCRC Road Section at 10:00 a.m same day.
